

HOST PROFILE

Don Taliman is a graduate of Penn State with a B.S. in Agronomy. Don has also been a member of the CPGCSA since 1976. Don was first a superintendent of Silver Spring Golf Course, then was a superintendent at Bala Golf Course and for the last 6½ years has been the superintendent at Green Valley Country Club. Don is married to Maryann and has 2 children.

COURSE PROFILE

Green Valley Country Club was built in 1912 by Tomey Flynn and remodeled by Don Ross in 1945. Dick Wilson, as well as many of Green Valley's past greens chairmen, have also added quite a bit of character to the course. Some of the construction projects have included: enlarging 16 trees, building three lakes and a waterfall on the 5th hole. Tees are Bent/Poa and greens are Bent/Poa. Green Valley is currently on a Cutless program. In the near future anticipated plans include, using Methyel Bromide and the 2nd green and then reconstructing the green and seeding with Penn Links. Number 4 fairway presently is being converted to bent. There has been over 1 mile of drainage installed and all irrigation is automatic. The course is par 71 and plays 6,737 yards from the blue, 6,299 from the white and 5,728 from the red.

This is a very exclusive private club with approximately 350 members. Other features include a swimming pool, 6 outdoor tennis courts, and also has indoor tennis courts.

1987 CODE OF ETHICS

The CPGCSA has adopted the GCSA Code of Ethics which are as follows:

- 1. Recognize and discharge all my responsibilities and duties in such a fashion as to be a credit to this Association and profession.
- 2. Practice and insist upon sound business and turf management principles in exercising the responsibilities of my position.
- 3. Utilize every practicable opportunity to expand my professional knowledge, thereby improving myself and my profession.
- 4. Maintain the highest standards of personal conduct to reflect credit and add to the stature of the profession of golf course management.
- 5. Base endorsements, either written or verbal by means of any medium, strictly upon satisfactory personal experiences within the item identified.
- 6. Refrain from encouraging or accepting considerations of any value without the express understanding of all parties that said consideration is available to all in similar circumstances, and that no actions shall be forthcoming as a result of acceptance.
- Recognize and observe the highest standards of integrity in my relationships with fellow golf course superintendents and others associated with this profession and industry.
- 8. Assist my fellow superintendents in all ways consistent with my abilities.
- Abstain from the untruthful debasement of, or encroachment upon, the professional reputation or practice of another superintendent.
- Lend my support to, and actively participate in, the efforts of my local chapter and National Association to improve public understanding and recognition of the profession of golf course management.
- 11. Abstain from any unfair exploitation of my Association, industry or profession.
- 12. Present information and participate as a witness voluntarily in all proceedings to which there exists evidence of a violation of this Code of Ethics.

EDITORIAL


The CPGCSA Code of Ethics appears in this newsletter. The purpose of printing the "Code" at this time is to refresh us as to proper, professional conduct.

The next 3-6 months will be the prime time for position changes among our members. This can be transacted in a manner which will elevate us all if done ethically and in consideration of all parties involved.

We would hope any and all changes of position would be the result of upward moves by the incumbent superintendent, but history shows that periodically some of us will be dismissed. What ever the reason for a job opening, professional courtesy should be observed. A phone call to the incumbent superintendent will verify the official opening of the position as well as provide vital information as to details of the job, etc.

No rule can or will mandate integrity. It can only be encouraged, fostered and nurtured through example. Actions do speak louder than words. If you put yourself in the position of the incumbent superintendent then the best course of action will be obvious. Fortunately, the CPGCSA has not been troubled with major ethical problems in the past. We can maintain that superior record, if we all choose the "High Road" when dealing with other members.


