

INSECT TIP OF THE MONTH

Want to get a head start on your insect problems for the season, especially your white grubs? You say you don't have a grub problem. Well here's one way to find out. In problem areas of the past or even in suspect areas, whether its on tees, fairways or roughs, locate the area and run your sod cutter through it, roll back the sod and if in fact you do have grubs collect a few in a jar and bring them back to your office for further examination. Don't worry about your sod, just roll it back in place and tamp it, this time of year it will heal back with no problems.

Now that you've captured your culprit it's time to identify the grub. Get out your white grub chart and start cross referencing with body shape, color, size, and with magnifying glass carefully identify the rastral pattern. With proper I.D. you must now determine proper time to treat and with which insecticide. Knowing what you have puts you way ahead of the game when it comes time to spray.



The Allied Goff Course Superintendents Association of Pennsylvania

With the increased attention given to environmental issues and with consequential new and pending legislation, it is becoming increasingly important for the superintendents of Pennsylvania to be represented and have a voice at the state level.

Historically, the Pennsylvania Turfgrass Council has represented Golf Course Superintendents along with the lawn care industry and other closely related professions quite adequately in regards to education, research, etc. But now with governmental issues becoming such a significant issue the PTC does not feel and should not be expected to assertively represent its membership to the government regarding controversial issues. This is because of a number of reasons. PTC was founded primarily to support education and research within the turf industry. Its close relationship with the Pennsylvania State University would put PTC in a precarious position if it was to directly get involved with governmental issues. The majority of the PTC membership is formed by the lawn care industry and the golf course industry. It would be difficult for the PTC to give equal representation in regards to key issues with intricate details to both the lawn care and golf course industry. Certain issues have and will affect the lawn care industry differently then the golf course industry.

Recently the Lawn Care Association of Pennsylvania (LCAP) was formed so that they can better represent themselves in not only governmental issues but in education, etc. They are now in the process of forming position papers focusing on governmental issues or new legislation.

It is necessary that the superintendents of Pennsylvania effectively collaborate or unite so that they can be heard as one voice on the state level. The foundation or framework for this necessity is already formed through our socially and politically motivated Allied Association. A board of directors could be formed for the Allied by appointing at least one board member of each chapter. This individual will serve as the liaison between the local chapter and the Allied, representing their chapters interests and ideas. Initially the main focus of this board will be governmental issues. Since forming this board is prompted by governmental issues and concerns, it would seem appropriate that each chapter appoint an individual responsible for or that chairs that chapters governmental or environmental committee.

In the Allied boards initial stages, one of its main goals will be to form position papers concerning governmental regulations. Of course, there are other questions and topics this board must address regarding the structure of its administration and membership etc. To dwell on the intricacies now would be putting the cart before the horse. The important thing is to start the ball rolling at this point.

Again, through the Allied the superintendents of Pennsylvania will be able to define and document their position on a state level. This will enable us to work together with closely related associations such as LCAP, PA Trade Alliance, etc. on overlapping areas of concern. This intern will alleviate any unwanted or undesirable responsibility of the PTC.

The forming of the Allied Board of Directors will not only enable the Superintendents of Pennsylvania to have one voice in the state but also will enable us to work with closely related industries in a more efficient and focused manner.

Please contact your board members and discuss this topic thoroughly with them. Put all concerns, thoughts, etc. in writing. We plan to have a meeting at the National convention sometime between the 8th and 11th. You will be contacted regarding the exact date.

"THE THINKING SUPERINTENDENT"

Our very first "The Thinking Superintendent" article comes from your past president emeritus, Mr. Robert Beyer, CGCS, from Outdoor Country Club, York, PA: Bob's tip concerns putting a circle around the pin on a par three hole during a tournament. The conventional way is to use marker paint which is still around long after the tournament. This is how Bob does it, "I use a predetermined length of rope looped around the pin, pulling the rope taut I walk backwards holding a 1 gallon plastic container with a pour spout, slowly po uring out a line of finely sifted white sand in my circle. This sans can be worked into the surface so as not to effect putting. After the tournament it can be swept away or worked completely into the turf." Thanks Bob.

TURF TIP OF THE MONTH

The majority of turf damage to both warm and cool season turfgrasses takes place in late winter and early spring when plant hardiness levels are at their lowest. At this time, thawing snow frequently results in standing water and increased water uptake by plants. Often a period of warm temperatures may touch off a spurt of growth which can lead to serious injuries. What can be done to prevent it?

- 1. Good aerification program;
- 2. Adequate nutrient levels for vigor;
- 3. reduce thatch;
- 4. higher mowing heights;
- 5. Keep traffic off turf during thawing;
- 6. Use synthetic covers;
- 7. Proper draining contours;
- 8. Use coursely textured soil.
