HOST SUPERINTENDENT PROFILE:

Tony is a 1971 graduate of North Carolina State University and has been a Superintendent for 22 years. He has worked at River Bend Country Club for 3 years, Loudoun Golf & Country Club for 12 years, and The Summit Golf Course for 3 years. Tony started as construction Superintendent at Heritage Hills in 1988 and has remained on as Superintendent.

COURSE PROFILE:

Heritage Hills Golf Resort started construction in April 1988 and opened for play in July 1989. It is considered a "fun course" at 6,100 yards with large greens and tees. The greens are Pencross bentgrass, and the fairways and tees are rye. Heritage Hills has an automatic Toro irrigation system. There are 62 bunkers and 4 ponds that will challenge you.

SPEAKER PROFILE KEN PEPPLE, **EDUCATIONAL CHAIRMAN**

CPGCSA BOARD NEWS

The CPGCSA membership met at Butter Valley on July 13, 1993 for the July meeting. The meeting opened at 5:50 PM with President Dave Rafferty thanking John Gehman for the wonderful day of golf. Guests were introduced. Secretary/Treasurer Sam Snyder reported that current expenses were \$7805.30, income of \$17,250.49 for a balance of \$9,445.19.

By-laws chairman Corky Knoll presented the by-law change and President Rafferty entertained a motion to accept. Whitey Krout made the motion and John Dougherty seconded. There were no member questions and the motion

passed unanimously.

Education chairman Ken Pepple introduced Bob Hesser who spoke on Pond Management. Bob stressed the need to periodically test your water sources and preventatively treat for algae and weeds. The pesticide roster sheet was circulated through the membership to receive the Category 9 credit for the program.

Golf chairman John Dougherty presented the golf prizes and the meeting concluded at 6:43 PM.

PTC AWARDS \$250,000 FOR TURF RESEARCH

The Penn State Turfgrass Research Program received a record allocation of funds from the Pennsylvania Turfgrass Council for the 1992-1993 fiscal year. The \$250,000 research grant brings to more than \$725,000 the association donated to Penn State over the last five years.

The Pennsylvania Turfgrass Council has a membership of over 1,200 comprised of golf course superintendents, lawn services, landscapers, grounds managers, industrial representatives, and many others. The Pennsylvania Turfgrass Council serves as the voice of all turfgrass interests in the state. Many of the research efforts that the PTC support help to lend credence to the public image as an industry concerned with its impact on the general public. The organization's goals are divided into three major areas: fund raising for research, extension, and education; conduct educational conferences and regional schools; and representation in the Turfgrass Industry. It is governed by an elected Board of Directors with turfgrass personnel from Penn State serving in an advisory capacity.

IOHN DEERE TOURNAMENT

Plans are set for the seventh Annual John Deere Regional Team Championship Tourna-The first tournament is set for Rolling Green Golf Club in Springfield, PA on August 24th. The second tournament will be at Turf Valley Country Club on October 11th. Each club may choose only one event to participate in.

The winning regional team qualifies for the National Championship in Palm Springs California, November 19-22. The foursome should consist of the *Superintendent, President, General Manager, and Golf Pro. The format is a modified scramble with limits on the team handicaps. Prizes, gift certificates and free use of John Deere turf products are among the team prizes.

Deere and Company will be donating \$20.00 per team which participates in our regional qualifiers, to the GCSAA Scholarship and Research Fund. Finch Turf Equipment will be donating \$10.00 per team to the superintendents association with the most participants for each tournament.

Each tournament is limited to the first 32 teams which respond. More information will be sent to each golf course superintendent in the Finch Turf Equipment territory.

*The Superintendent must be a member of the National GCSAA in order to go to the national event. Non Membership does not prohibit entry into the regional tournaments.

BYRON NELSON TO RECEIVE GCSAA'S HIGHEST TRIBUTE

Golf legend Byron Nelson will be honored as the 1994 recipient of GCSAA's greatest honor, the Old Tom Morris Award.

The award will be presented Feb. 7 during the closing banquet of the GCSAA Conference and Show in Dallas, Texas. Dallas is home to Nelson and his namesake PGA Tour event, the GTE

Byron Nelson Classic.

In announcing the GCSAA board of director's choice for the 1994 award, President Randy Nichols, CGCS said, "There is probably not a nicer man in golf. Even though he officially retired from the pro tour nearly 50 years ago, he constantly gives all that he can back to the game.

"GCSAA is honored to include this gentleman among its list of Old Tom Morris Award win-

ners."

That impressive list includes Arnold Palmer, Bob Hope, Gerald Ford, Patty Berg, Robert Trent Jones, Gene Sarazen, Juan "Chi Chi" Rodriguez, Sherwood Moore, CGCS, William Campbell, Tom Watson, Dinah Shore - and now Byron Nelson.

Nelson's accomplishments in golf include Masters victories in 1937 and 1942, the U.S. Open Championship in 1939, and PGA championships

in 1940 and 1945.

In 1945, he won 18 PGA Tour events, including 11 consecutive victories—a feat that remains untouched —unapproached —in the record books. The closest anyone has come since was when Jack Burke Jr. had four consecutive wins in 1952.

Ben Crenshaw, 1984 Masters Champion and a close friend of Nelson's, has said, "To those of us lucky enough to know him through the years, he has been the kindest, gentlest man, especially to young people. He will be remembered much more for the way he lived his life and how he tried to help people in any way he could."

The GTE Byron Nelson Classic is just one example of Nelson's community contributions.

For more than 25 years, the tournament has raised money for the Salesmanship Club, an organization that Nelson helped establish. The club sponsors camps and education centers for troubled youths.

Nelson's autobiography, How I Played the

Game, is now available in bookstores.

GCSAA established the Old Tom Morris Award in 1982 to recognize individuals who have made outstanding lifetime contributions to the game.

The award is named in memory of Old Tom Morris (1821-1908), greenkeeper and golf professional at the Royal and Ancient Golf Club of St.

Andrews, Scotland.

EXPECT DALLAS SHOW TO BE BIG-GEST EVER




