It's now June 15th and we have already experienced a little dryness, a little humidity, and a little heat. Mother nature's way of warning us of what is sure to come as summer goes on.



GCSAA offers Employment Referral Service

The national unemployment rate continues to hover around the 7-percent mark, where it has been for much of the past three

years.

Although the golf industry did not suffer as badly as many other industries, the recession did have an impact. Many clubs saw revenues stagnate or decline as members weathered personal economic crises, or as related real estate developments failed.

Some of these tried to cut corners on golf course expenses by reducing the personnel budget — cutting staff or replacing more experienced, higher paid workers with less experienced, lower paid workers.

Others cut the maintenance budget to the quick, and when they became unhappy with the quality of the golf course, they traded in their superintendent

for a miracle worker.

GCSAA members who are seeking new positions in the golf course management field — whether because of economic necessity or personal desire — can learn about job openings through the association's Employment Referral Service (ERS).

ERS subscribers receive weekly listings of job openings throughout the United State and abroad.

According to a 1992 survey, 62 percent of ERS advertisers said they filled the position with a candidate who responded through the service, and 93 percent said they would use the ERS to fill another position.

Special GCSAA S & R Grants Offered to Graduate Students

Outstanding graduate students in the field of golf course management education and research now have a new grant program available to them.

The GCSAA Graduate Student Grants Program will provide annual awards of \$5,000 to individuals pursuing advanced degrees in academic fields related to golf course management.

The goal of the program, sponsored by the GCSAA Scholarship and Research Foundation, is to identify and encourage tomorrow's leading educators and researchers.

To be eligible, students must be currently enrolled in a master's or doctoral degree program related to golf course management. Students must also plan to pursue an academic career in a university setting.

Applicants will be evaluated on academic excellence, potential to make outstanding contributions in research and education, peer recommendations and previous accomplishments in their field. In addition to the cash award, winners will received an expenses-paid trip to the GCSAA International Golf Course Conference and Show.

The deadline for applications is October 1. Awards will be presented in early February. Application forms are available from the GCSAA development department (913/841-2240).

PENN STATE CLIPPINGS By ANDY MCNITT

Penn State's Turfgrass Museum is being expanded, updated, and set up for public display. The museum will be housed in a new building at the Landscape Management Research Center.

Dr. Pete Landschoot reports seeing several cases of red leaf spot on creeping bentgrass. Lesions are small and difficult to observe without a microscope. Stand symptoms appear as a brown or rust color and thinning can occur in severe cases. Most of the cases thus far have been in central and western PA. Daconil or Chipco 26019 are effective in controlling this disease.

George Hamilton cautions that superintendents be aware that the use of the sterol inhibitor fungicides on Cutless or TGR treated turf can cause a compounded effect. Remember, the full effect from a growth regulator may not be seen for 5 weeks.

Mike Soika reports that the cool, wet, conditions of the 1992 growing season may have caused significant root infection by the fungi that cause patch diseases (take-all, necrotic ring spot, summer patch). Symptom expression was minimal in 1992, due to a lack of environmental stress. However, growers should be alert this season for early and severe patch disease potential. Many of the samples received already this year have shown heavy root infection by patch fungi on bluegrasses and bentgrasses. Symptoms at this time may appear as yellowed, bronzed, or stunted irregularly-circular patches. Roots of affected plants can be checked for patch fungi by washing well to remove soil, and examining with a hand lens for the presence of dark fungal threads on the root surfaces. If such fungi are found, fungicide treatment is required, even though the exact identification of the fungus is not known. A possible treatment regime may be:

on Kentucky or annual bluegrasses - a high rate of Banner alternated at 28 day intervals with a high rate of Chipco 26019

on bentgrasses - a high rate of Bayleton alternated at 28 day intervals with a high rate of Banner

To be effective, fungicides must be applied in the morning to wet foliage and immediately irrigated (1" water) into the root zone.

Kerry Hoffman says watch for changes (relatively minor) in record keeping requirements for restricted use products. The federal government

has passed legislation mandating that states implement requirements that meet the Feds standards. Pennsylvania should have to make only minor changes to be in compliance. Kerry also reports that the hypersensitivity list notification will become mandatory.

I want to thank the Philadelphia Golf Course Superintendents Association for funding a study of commercially available topdressing mixes. The survey provides the chemical and physical properties of the top dressing mixes studied. The authors feel that the most useful information in the report, is the review of testing procedures and test result interpretation. This information should prove useful when considering testing for future green's construction mixes or in interpreting the results of tests from other labs. The report is available on PENpages, Cooperative Extension's computer data base. A copy is available through any local Extension office. Be sure to remind the office that this report is on Penpages. Presently the Agricultural Experiment Station here at PSU is reviewing the report. Our hope is that they will decide to print the report as an AG. Exp. Station progress report.


