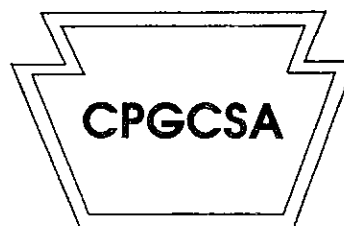

Superintendents Announce Officer & Board Election Slate

Bruce R. Williams, CGCS, has been nominated for the presidency of the GCSAA. The association's 1996 election of officers and directors is scheduled for Saturday, February 10, during its annual meeting at the GCSAA International Golf Course Conference and Show in Orlando, Fla. Williams, superintendent at Bob O'Link Golf Club in Highland Park, Ill., currently is vice president of GCSAA.

The nominee for vice president is Paul S. McGinnis, CGCS, of Union Hills Country Club in Sun City, Arizona. McGinnis currently is secretary/treasurer of the association.

The nominees for secretary/treasurer are Dave Fearis, CGCS, of Blue Hills Country Club in Kansas City, Mo; and George Renault III, CGCS, of Burning Tree Club in Bethesda, Md.

Six candidates will vie for two director positions. The nominees are Paul A. Dermott, CGCS, of Oakdale Golf & Country Club in Downsview, Ontario, Canada; Ken Mangum, CGCS of Atlanta Athletic Club in Duluth, GA.; Samuel Snyder VII, CGCS, of Hercules Country Club in Wilmington, Del.; Robert J. "Bob" Tillema, CGCS, of Sherwood Forest Golf Club in Sanger, Calif.; Michael Wallace, CGCS, of Hop Meadow Country Club in Simsbury, Conn.; and R. Scott Woodhead, CGCS, of Valley View Golf Club in Bozeman, Mont. Both Wallace and Woodhead currently serve on the GCSAA board of directors. GCSAA directors serve a two-year term.

Secretary/treasurer candidates Fearis and Renault each have one year remaining on their current terms as director. In accordance with GCSAA bylaws, the incoming president will make an appointment to fill the director's seat vacated by the successful candidate for secretary/treasurer.

GCSAA's current president, Gary T. Grigg, CGCS, of Royal Poinciana Golf Club in Naples, Fla., will continue to serve on the board of directors for one additional year as immediate past president.

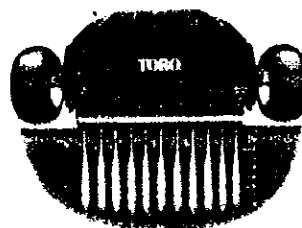

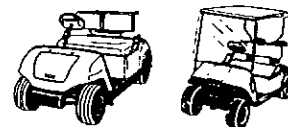

I wasn't going to do a product review this month but a demo was dropped off last week which has truly impressed me.

I went to a local tractor dealer for some parts the other day and saw a little Kubota lawn tractor sitting on the show room floor. That's nothing unusual, but what caught my eye was a ball joint on the rear axle and the words "4-wheel steering" on the fender. Although I wasn't in the market for a new mower, I showed just enough interest that the salesman dropped it off a day later for me to try. Suffice it to say the the 60" belly mower powered by a 19 horsepower diesel engine has gobbled up, spit out and finely manicured everything I've run through it so far including thick rye grass first thing in the morning after 2 inches of rain, 2 foot high weeds and a huge rock. (Well, actually the rock never came back out! But it's a demo, who cares, right?) The four wheel steering makes quick work of cleaning up around trees and posts. It's not going to replace my out front rotary but it is definitely an alternative to adding a second out front to the fleet.

Parents of Boy Hit by Truck Give Update

Bee Attack Led to the August Accident on Calvert Road

EDITOR'S NOTE: The letter below is from the parents of Rory Brown, a 12-year-old Calvert boy struck by a truck on Calvert Road on August 23. Rory was using a weed trimmer alongside the road when he ran from a swarm of bees and was hit by a truck. He has been hospitalized with critical head injuries.

On behalf of our family, we would like to thank everyone for their prayers, concern and support offered for our son, Rory Brown, and our family.

To update many of you, Rory received significant head injuries in his accident and remains in a light coma. Fortunately, there were no broken bones or other internal injuries and, after some setbacks due to infection, he is presently out of the intensive care unit and awaiting rehabilitation.

With much reservation for fear of excluding someone, we would like to publicly thank both our volunteer fire department and county paramedics, as well as the state police and Medevac helicopter crew for their prompt actions after the accident.

We deeply appreciate the generosity and love expressed by the staff and children of the Calvert Elementary School, the Rising Sun Community Little League, and the Ladies Golf Committee of the Chantilly Manor Country Club. Rory has been showered with cards and offers of encouragement and support.

Our church, Grace Bible Chapel, along with friends and neighbors on Calvert Road in Zion, have simply overwhelmed us by providing meals, transportation, child care, and house cleaning. Judy and I feel like the lead characters in the movie, "It's a Wonderful Life", when at the end of the movie, the whole town comes out in support. It has been so gratifying.

We do not know what the future holds for Rory, but we do know that nothing happens by chance. We have placed Rory in the hands of God, as have many other Christians that have supported him in prayer over the past weeks. We hope that they will continue to do so into the future.

God is in control! We know that He is not up in heaven wringing His hands in panic, wondering what He is going to do next about Rory. He has a plan.

If you are a parent, you might wonder how you would react in a life and death situation with your child. We used to wonder, too. We have found, however, that when you have Jesus Christ as your Lord and Savior, He gives you grace to meet the situation and peace to accept His sovereign will.

And through it all, He uses people like you as instruments of His love.

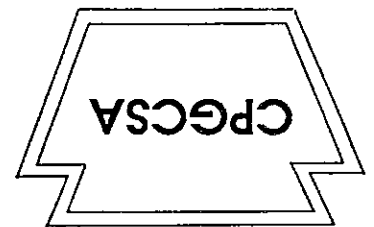
