USGA "Tip of The Month"

When most of you read this, fall renovations will not be far from your thoughts. In our recent travels, several courses have already started aerification, and many others are anxious to get the process started.

One thought to keep in mind for green renovations is to treat weaker greens gently during this process. They tend to get beat up during renovation. This may include utilizing hand brooms to work in topdressing on some of the weaker greens. This is labor intensive, but generally benefits the green. Too often we see superintendents work hard to keep a problem green alive through the summer, only to severely damage it during the renovation process, usually through the process of incorporating topdressing.

This is a good time to reiterate an earlier message from Keith Happ: Communicate, Communicate, and Communicate! Communicating with all parties involved is crucial for smooth fall renovations. Oftentimes, players feel the golf course is in excellent condition, and the superintendent is destroying it! Let people know what to expect and what you are trying to accomplish during the renovation process.

For those with perennial ryegrass fairways, cases of Grey Leaf Spot have been reported from Philadelphia to Pittsburgh. Most have occurred in taller cut turf of the intermediate and primary rough. University of Maryland Pathologist Dr. Peter Dernoeden states that this disease can occur well into October under the right conditions. Be aware the disease is active in our region.

Hopefully the weather will cooperate, and it will be a good fall for everyone.

Proposed Bylaws Changes

Proposal: Change Affiliate Member ratio from 30% to 40%

Section 6.11. Class AF - Affiliate Members. To qualify for affiliate membership, an applicant must be a person interested in the growing, management or production of turf grasses, either individually or through employment by, or other affiliation with, a company, proprietorship, or association, who does not qualify for membership in another class. Affiliate members shall have all privileges of the association, except those of voting and holding office. Affiliate members shall not exceed forty (40%) of the total of Classes AA, A, B, C, and voting R members with the following exceptions: A bona fide turf oriented company may be granted one (1) membership representative into the association, regardless of the Class AA, A, B, C, and voting R members to commercial ratio, provided they are not presently represented in the association. He or she shall pay fees, dues, and assessments.

Proposal: Add Student Classification

Student - To qualify for Student membership, an applicant must be a full time turfgrass student enrolled in a formal course of education, or have completed his or her formal education less than one year prior to the date of application for membership.





Why Fast Greens?

Last month in the "President's Message", John Gehman asked an interesting question after playing two local country clubs. "Why do greens have to be so fast?" I see John's name on Turfnet all the time so I know he enjoys some good controversial answers every now and then! So I figured I would try to respond to the question and I hope most of you can relate.

First of all, I've been asking that same question for a few years to the different members I've worked for and have finally come up with an answer in my present job situation....Because I have too! I don't have a choice. I am sure that Superintendents in a country club setting feel the same way. Raising mower heights in the hot summer months is not an option. Without fast and smooth greens on a daily basis, I'm under the gun. Give 'em a manicured golf course...good tees, fairways, bunkers, etc. while having greens that don't roll 10 and above and the course is just OK.

Am I targeting the entire membership with ultra fast greens? Absolutely not! The Greens Committee has directed me to do so. And if I don't I will hear about it! John, I am in agreement that the average player cannot even play these greens, and will say they are unfair, but they are not speaking out. I have never seen a letter to the Greens Committee or Board of Directors complaining that the greens are too fast.

So for the past 3 years I've been investigating methods of how to keep greens consistently fast while maintaining health. 90% of the gray hairs and stress these days comes from less than 2 acres of turf. Well...Gray leaf spot has caused a bit too! But you know what I mean.

And so John, the fast greens are not by our choice, but our Greens Committees. In the 60's, US Open green speeds were about 8.5 feet. Now we hear of speeds of 12 and 13. I think "Augusta National Syndrome" has set in and is getting worse.

Through all of this, I have learned 2 important things. Algae infested greens roll fast and dead greens roll even faster. Just make sure there are no green patches in between to deflect the golf ball. I've also learned that when my Greens Chairman tells me the greens are too slow, I can't respond by saying "just hit it a little harder!

Heather And Gorse

I get a kick out of the "Joe Homeowners" of the world who year in and year out attempt to maintain their lawns and land-scapes by themselves. In my "hood" there is a resident my wife and I call "Navy Man" (we won't mention his real name for fear that he may somehow acquire a bootleg copy of this newsletter). Anyway, every April, "Navy Man" burns up at least on third of his yard by misapplying fertilizer. The first year he was our neighbor, he had just bought a brand new spreader. Judging by the width of the serpentine dead grass bands every three or four feet apart, my guess would be that he purchased an 18" wide, drop spreader. I've always theorized that there was a gigantic, governmental, global-thermo-nuclear, pathenogenic, epidemiological chemical conspiracy that started a decade ago or so, and has continued to this very day. Think about it, remember when things were much simpler? The Rules of the Game

Rule 18-2a/decision 26: Ball dislodges from tree when player climbs to play stroke.

Question: As a player is climbing a tree to play a ball lodged in the tree, the ball falls to the ground. Does the player incur a penalty?

Answer: Yes, under Rule 18-2a, the player is penalized one stroke, and the ball must be replaced.

Now, what if, a player could not find his ball. Believing the ball might be lodged in the tree, he shook the tree and his ball fell to the ground. He played the ball from where it came to rest. What is the ruling?

Answer: The player incurred one penalty stroke under Rule 18-2a for moving his ball. He should have replaced his ball. Since he did not do so, in match play he lost the hole and in stroke play he incurred an additional penalty stroke, or a total penalty of two strokes.
