Mid-Atlantic USGA Update

Is It Over? Begin Marking Your Calendar

The summer of 2005 is one many turf managers will want to forget. You should always look forward, not back, but there could, however, be an exception to this rule.

The 2005 summer presents an opportunity to learn both what worked and what did not work in the programs, practices, and products used on your golf course. Make written notes now on your 2006 calendar, and don't rely on your memory. The considerations should include:

- When you may want to switch from grooved to solid rollers. June 15? July 1?
- Dates to plan on RAISING MOWING HEIGHTS.
- Approximate dates to surface aerate greens. How does this fit into the golf schedule? Adjust accordingly, but plan on keeping your greens vented in a non-disruptive way.
- General chemical applications programs for next season. While such a schedule can and should change, this is a good exercise in planning ahead. Always tank mix and rotate fungicide chemistries. Never combine growth regulators with fungicides that have growth regulating side effects in the same tank, don't apply pre-emerge herbicides too late in the spring, the approximate time growth regulators should be applied, etc., etc., etc.
- When major putting green (and golf course) renovations are scheduled. This is a good opportunity to plan pre-fertilizations, timing the gaps between growth regulator applications, ordering topdressing, etc.
- Dates for fertilizer applications, including supplements recommended by soil test results.
- Schedule dates to take soil tests (see above).
- Indicate turf conferences you and your assistant superintendents should attend. There is a lot happening in the industry and it is important to stay current. Invest in education.
- Vacation dates. Every living thing (including grass) needs a break. Did you push the grass too far this summer? Are you pushing yourself (and your family) too hard now? Ouch.

Mark your calendar with a reminder to give a special thank-you to everyone who works for you and for whom you work. It has been a tough year for everyone.

In conclusion, while there is a natural tendency to forget a bad year, the fact is, it is an opportunity to learn. No one knows what the future holds, but after this year no truer words were ever said than the old Boy Scout motto, "Be prepared."

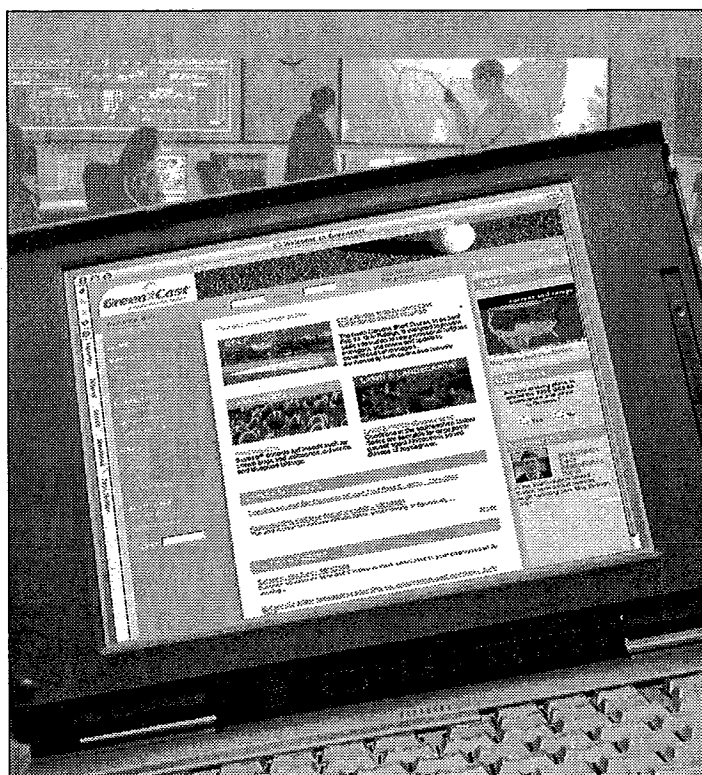

Heather and Gorse

Wow! Y'all remember that commercial back in the 1970's with that catchy phrase "Don't mess with Mother Nature!"??? Seriously, I don't even remember the product that was being promoted, but following a summer like this past one, I think we've all received a grim reminder that Mother Nature certainly commands a level of respect. It seems like it has been while since we've had a summer similar to the shock and awe that this summer has brought. I know the scarring of many turf surfaces was indiscriminant, regardless of turf species and budget. It seemed it wasn't a matter of whether or not you were going to lose turf... It was more a matter of how much turf you were going to lose!

So, just how bad was it? I guess it depends on your perspective. If you compare this summer by temperature alone, the summer was the fifth warmest on record dating back to the late 1800's. We've experienced 27 days of temperatures over 90 degrees F. That being said, 2002 was a bit more intense with 46 days above 90 degrees. I think the differentiators for 2005 have been two things... The average daytime temperature has been higher and the amount of precipitation has been closer to normal compared with 2002.

It is interesting how quickly we all forget the past... Or just maybe it is an indication of how youthful the average age of the golf course superintendent has become... The four summers warmer than 2005 all occurred within a five year time span from 1991 to 1995. In 1991, we experienced 53 days of greater than 90 degrees! Unfortunately, I remember this stretch rather well... Similar to this past summer in that from July 4th onward to Labor Day, for nearly five straight years, you were in absolute survival mode. Turf death was not an option, it was an absolute and it was all a matter of how to minimize your losses.

In our region, July 18th, 2005 was the tipping point and/or the beginning of the end for many. Root systems were underdeveloped as a result of a relatively cool, wet spring; we had gone from the frost to the furnace about four weeks earlier; and it was about that time that we were coming off of a four to five inch precipitation saturation from the remnants of Hurricane Dennis.

It was during this time period that the reports of root pythium, pythium blight, summer patch, anthracnose, and wet wilt started popping up out of the puddles. Anyone with marginal drainage and most of those with *Poa annua* started to experience first hand, Darwin's Theory regarding survival of the fittest! Those with excellent drainage and good water management capabilities seemed to fair OK. Those with anything less got banged up.

From that fateful third week of July to present, it has been a blood bath, with the only saving grace being that the day length and the angle of the sun are such that summer is on its way out. The advent of yellow school buses, along with a few mid 50 degree nights has signaled the end of another turf war and it is now time to pick up the pieces and attempt to reconstruct your golf courses. The problem is that Mother Nature isn't quite ready to let the turf recover, at least with any of her help. While we've had some beautiful September weather, it has been so dry that many people are starting to experience strains on their irrigation systems. It seems like the challenges of 2005 may never end.

If it is any consolation, I believe it safe to say that our troubles these past few months most certainly pale in comparison to the troubles experienced down in New Orleans and Biloxi. I will always remember the first time I attended the GCSAA National Conference in New Orleans back in the early 1990's. The motel shuttle bus driver gave us passengers a historical perspective on how the city was below sea level, but had this wonderful pumping system! At the time I thought about how ingenious the French must have been during the original construction of the city. Now nearly fifteen years older and wiser, I'm perplexed by just how ingenious the French must have been during the construction of the city! French engineering... Some of the finest in the world! OK, I know in actuality that the French had little to do with any part of the city outside of the French Quarter, which went essentially unscathed during Katrina due to being located on higher ground... So I guess they've got that going for them!

Seriously, it has been unbelievable watching the death and destruction at the hands of Katrina. And of course hindsight is always 20-20. Why didn't more people heed the warnings and evacuate? Why did it seemingly take so long for relief to arrive? Why did they ever build the city on the gulf, below sea level? Why did they rebuild the city in the same spot 40 years ago after Hurricane Betsy besieged and flooded the city in 1965? I'm sure many of these questions will be debated and will remain unanswered until the next time a disaster of this magnitude occurs.

As for the overall chaos, the looting, and the general anarchy, well now, that's a whole different story. I'm not sure any of us can imagine what it would be like to experience a week like this. No food, no clean water, no bathrooms, no home, etc. Dead bodies floating down the avenue! Human behavior can be an awfully funny thing, especially when your life and the lives of your family are at stake.

There is a famous behavioral study called the Stanford Prison Study, which illustrates how our environment so substantially influences our behavior. I believe much of the insanity that was taking place in New Orleans had to be a direct result of the

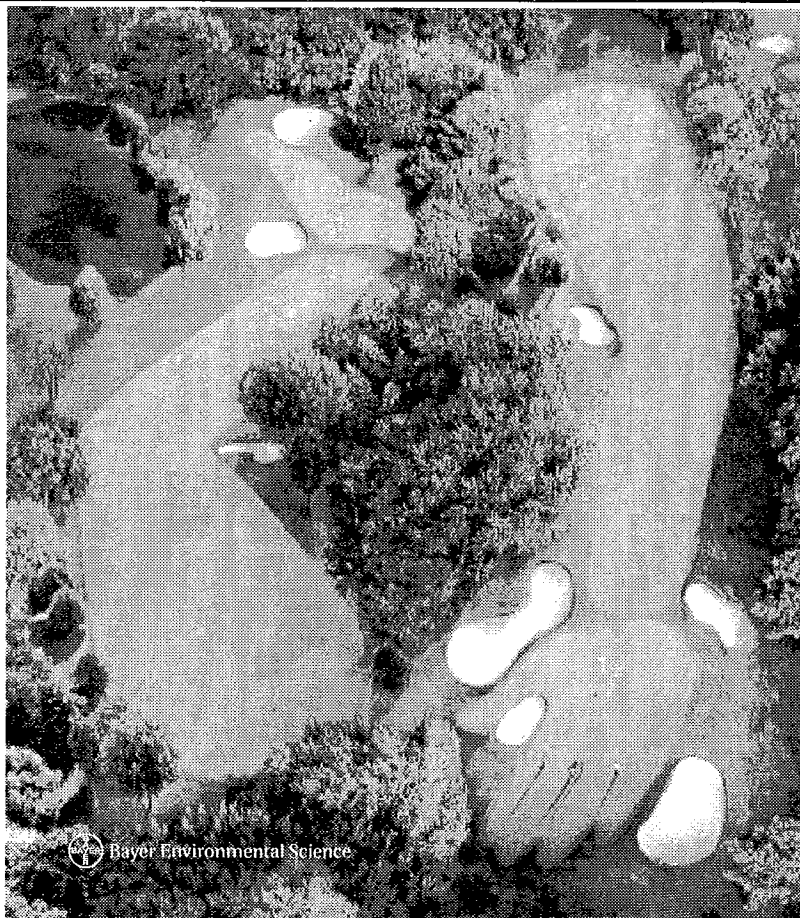
environment... At least I hope and pray it was directly related to the environment, because if it wasn't then there are some crazy ass brothers and sisters down south.

GCSAA Conference Relocates

New registration dates and event information

Because of the situation in New Orleans, conference information was not mailed with the September issue of *Golf Course Management* magazine as originally planned. The following is a new schedule for mailings and registration opening dates:

- **GCSAA National Championship and Golf Classic.** Plans now call for the golf championship brochure to be mailed with the October edition of *GCM*. Registration, housing and travel for the golf championship will open Oct. 18 and be extended until Dec. 16.
- **GCSAA Education Conference and Golf Industry Show.** A revised conference and show brochure is being produced and is now scheduled to be mailed Oct. 24. Member registration for the conference and show, housing and travel will now open Nov. 1, with open registration to follow shortly thereafter. Registration will then continue through the event in Houston. The event information available at golfindustryshow.com also is being updated, though much of the educational information will remain the same.

GCM Mailing Delayed

Because of postal issues surrounding Hurricane Katrina, mailing of the September issue of *Golf Course Management* magazine was delayed. The magazine has now been mailed, but is likely to be at least a few days late.

CPGCSA Scholarship

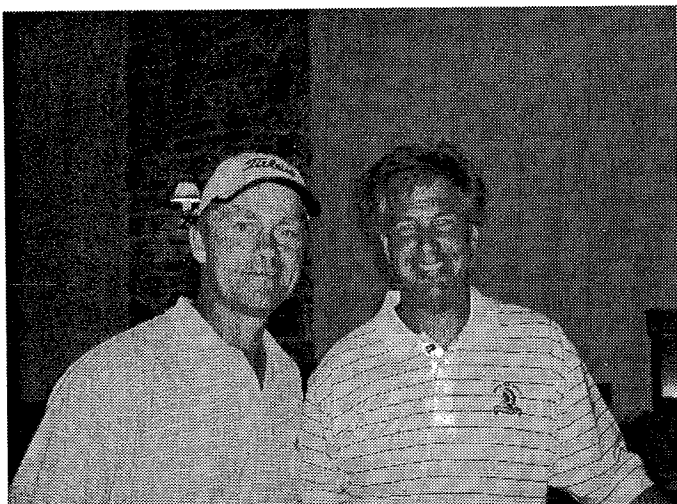
