Mid-Atlantic USGA Update

Early Spring Weather Has Been Good For Courses, Good For Golf

Finally, we have what some would consider a mild spring. After several years of seemingly cold springs, 2006 has been a welcome change. If you do not think so, just ask the superintendents who are growing bermudagrass!

Overall, throughout the Mid-Atlantic Region, golf course conditions have been very good. Mild temperatures and dry weather have allowed most courses to complete aeration programs and other projects in an efficient manner. Healing of aeration holes on greens is complete on most golf courses, although some courses that aerated later are still seeing some open aeration holes. Overall, the dry weather has been a blessing for a region that desperately needed a good spring to get golfers out on the course.

Growth regulator applications for *Poa annua* seedhead suppression have produced variable results on greens and fairways. Golf courses that treated both areas have achieved good seedhead control in fairways or greens, but rarely both. What does this tell us? Quite frankly, we are not sure. Conventional wisdom tells us that this is a timing issue. Seedheads generally emerge earlier on fairways than on greens. Could those who received good control on fairways have applied too early on greens? Conversely, did those who had good control on greens apply too late for fairways? These are questions to ponder as we approach seedhead season in 2007. It also is important to have

Now also is the time to start preparing your membership or customers to the fact of impending restrictions for irrigation. Communication! Communication! Communication!

Our next meeting is set for May 16 at Harrisburg North GC. For those of you who have not played there, the golf course is fun and challenging. So take a break from the rat race of your course and enjoy a meeting! You may even learn something along the way! See ya there!

reasonable expectations for seedhead control. In some instances, less than 100% control has superintendents screaming failure, when in fact, control may be very good compared to not treating at all. Also, growth regulators improve putting green playability by slowing the vertical growth of the *Poa annua*'s seedhead panicle. Therefore, even though seedheads may be present, overall putting green playability is reasonably good. Certainly, better than if nothing was done. Remember to leave a check plot or two for seedhead applications in the future to compare treated and untreated areas.

Take the time now to consider what changes you will make in your maintenance programs when the summer stress season arrives. Do not wait until problems develop on fine turf areas to implement more conservative maintenance practices. If 2005 taught us anything, we should know to raise mowing heights on greens, limit mechanical stress (no grooved rollers), and to communicate to course officials about the potential damage that may occur to fine turf areas if management practices are not changed. July may seem like a long time from now, but it will be here before we know it. Will you be ready?

Finally, the one disadvantage of the dry weather patterns is the potential for drought restrictions to be imposed. Take the time now to determine what your water management authority requires for compliance with a drought emergency prior to implementation of restrictions. Acting now will help to avoid unnecessary stress or delays in water allocation when or if restrictions are imposed.
