Mid-Atlantic USGA Update

Fall Thoughts

Colder temperatures have arrived. Some warmer temperatures are forecast in the short term, but by the weekend freezing temperatures will dramatically reduce turf growth rates in much of the region. Maintenance programs are quickly changing to drainage projects, tree management, and other tasks that are difficult to complete during times of normal maintenance. Leaf removal also is an ongoing task. While a full staff is not required during the winter months, be sure to retain enough employees to allow necessary work to be completed, especially course improvement projects.

Unfortunately, several courses have pushed aeration of greens and fairways into later October to accommodate the fall golf schedule. In these cases, open holes will likely persist, leading to very bumpy conditions when weather is suitable for play in the latter part of the fall and winter. There could also be green aerator holes next spring! If these conditions are to be avoided, aeration must be scheduled earlier in the fall when the grass is actively growing so healing from aeration occurs before cold weather slows turf growth rate.



Color Abounds. . . And So The Work Goes On!

As attentions are turned to collecting and removing leaves from golf course turf, questions continue to arise. For example, should leaves be removed or can they be mulched and returned to the profile via large mulching mowers? Do all the leaves need to be removed? Will a layer of leaf litter create a problem next spring and summer?

By far the best strategy is to remove the fallen debris from the turf. Leaves can be collected and composted off-site and then used on other areas of the property. An aged compost product can be topdressed into areas of the rough that often do not have the best soil conditions. It will take time to develop a useable product, but benefit can be gained from topdressing with an aged, processed compost over perimeter areas of the course.

Insect damage is exposed as leaf collection efforts begin. Sweepers and blowers easily dislodge damaged areas of turf. The insect populations have fed aggressively on the root structures of the turf, resulting in large carpet-like sections of turf being turned over or turned up in the wind. Chart these areas this fall to allow for the use of insect control products next year. In some instances, an integrated strategy of using two insecticide treatments may be needed on site-specific areas next season.

Many superintendents have overseeded Bermuda grass fairways and portions of rough with ryegrass. Questions concerning germination rates of the ryegrass seed have followed. Some have expressed concern over delayed germination this fall. Those that have experienced this problem may want to contact suppliers and request information about the harvest dates of the seed. Freshly harvested (new crop) seed will germinate slower.

NOTICE:

The GCSAA Golf Course Environmental Profile Project is underway. The goal of this project is to collect information on golf course properties including details about the playing surfaces, natural resources, environmental stewardship efforts and management practices. The GCSAA has contracted the National Golf Foundation (NGF) to help implement a series of surveys to collect the necessary information.

The information collected will provide baseline data for documenting change and progress and help to set priorities for education, research, and other environmental programs. Each individual survey will be repeated at five-year intervals so progress can be documented over time.


The GCSAA sent the water use and conservation survey electronically on Monday, October 9, to all superintendents with an e-mail address. In addition, paper surveys were sent and they should reach superintendents by Friday, October 13, or early in the week of October 16. The more participation the better! The survey is to be completed and returned the GCSAA by Monday, November 20. Your participation is important. This information will be good for the game of golf and the turfgrass management industry.
