## **Superintendent Profile**

Lebanon Country Club is a typical example of a course built in the 1920's with small poa/bent greens, tees that are a mix of many cool season grasses, and ryegrass fairways.

## Mid-Atlantic USGA Update

### Wear And Tear

## Now Is The Time To Evaluate Procedures

Now is the time to evaluate mowing patterns and the resulting wear from a summer's worth of regular course preparation procedures. If excessive machinery overlap caused problems, adjust the tactics being used to allow the turf to heal. For the short term it may be necessary to use smaller lightweight equipment to complete mowing tasks. In some instances collars and approaches may have to be redefined to allow for total recovery before winter weather arrives.

It's time to introduce new seed into damaged areas. There are many new varieties from which to select. Check the National Turfgrass Evaluation Program (NTEP) results for performance data for your area or similar climatic conditions before purchasing seed.

If seeding is to be performed, seed-to-soil contact is essential to successful establishment of new turf. Some level of soil disruption is necessary to begin the recovery process. Areas that have succumbed to weather conditions will need to be aerated so that there is every chance of establishing newer generation grasses.

We continue to see Hyperodes weevil populations in many portions of the region. All stages of the life cycle have been observed. Control as many adults as possible this summer. Where populations have been controlled, the turf has responded. For example, despite the weather extremes, rough grasses bordering greens, tees and fairways have fared well. Uniform conditions have been sustained due in no small part to the use of sound pest management techniques.



# Directions to Lebanon Country Club

#### From PA Turnpike:

Route 72 North to 322 West towards Hershey. Approximately 5 miles make a right onto Route 934 North. Make second right onto Church Road. Church Road will end at stop sign and Oak Street begins. Go straight to Y, stay left of Y. Club is ½ mile on left on Oak Street.

#### From I-81:

Take 934 South through Annville. Make a left onto Royal Road. At the second stop sign make a left onto Oak Street. Club entrance is ½ mile on left.

#### From Harrisburg via Route 322:

Route 322 East through Hershey. Make a left onto Route 934 North. Make right onto Church Road (second road). At the stop sign go straight to Y, stay to left of Y. Oak Street begins, the club entrance is ½ mile on the left.

#### From Reading via Route 422:

Take Route 422 West to Lebanon till 16th Street. Make a left onto 16th Street. Three blocks to Oak Street. Make right onto Oak Street. The club entrance is on the right (2 miles).

#### From Lancaster via Route 72:

Route 72 North to Route 322 West towards Hershey. Approximately 5 miles make right onto Route 934 North. Make the second right onto Church Road, go to stop sign. Go straight to Y, stay to left of Y. Oak Street begins and the club entrance is ½ mile on the left on Oak Street.



## **Heather and Gorse**

## Heather and Gorse.....





#### So exactly how do I record points?

Be sure to visit <u>Member Central</u> on the GCSAA Web site at <u>www.gcsaa.org</u>. <u>Member Central</u> is your one-stop shop for managing your Class A requirements. It will allow you to record education and service points, as well as view your transcript for either your current renewal cycle or a comprehensive, lifetime record.

- Education points for pre-approved non-GCSAA educational events. An event approval code will be announced at some point
  during the program. To record your attendance, you must submit the event approval code to GCSAA by using either the online education point affidavit available in <u>Member Central</u> or a traditional paper affidavit.
- Education points for educational events without GCSAA pre-approval Submit the "Member Application for GCSAA Education Points" available in <a href="Member Central">Member Central</a> under the external education section to request a review of an education program. Applications must be submitted within 30 days of the event. If the program meets the criteria for education points, staff will record the education points to your transcript.
- Education points for GCSAA seminars & Web casts You must complete the evaluation form given at the end of the seminar and return it to the instructor. The evaluations will be scanned and the education points automatically recorded.
- Education points for attending the GCSAA Education Conference and Golf Industry Show You must be registered as a full-pack attendee in order to receive the 1.5 education points that are awarded for attendance at the GCSAA Education Conference and Golf Industry Show. Your points will be recorded automatically following the conference.
- Service Points Service Points can be recorded using the online service point affidavit available in <u>Member Central</u> or by submitting a traditional paper affidavit. A few categories require additional documentation be provided. For a complete list of the service point categories, visit <u>Member Central</u>.

If you do not have access to the Internet or would prefer to use a paper affidavit, we have developed a special automated, 24-hour Fax-On-Demand telephone system at (888) 838-4419. Upon request, a blank education or service point affidavit form will be faxed to you. After completing the appropriate affidavit, mail or fax (785) 832-3643 the form back to GCSAA where staff will update your transcript. You can also request these forms by calling the GCSAA Member Solutions at (800) 472-7878.







## Lebanon Country Club Hosts Research Field Day





## Take Care to Sidestep the Pitfalls Of Employee Discipline

Since they don't spend a lot of time practicing the art of discipline, it's no wonder most managers aren't very good at it. Unfortunately, correcting errant workers is part of the job, so learn to avoid these pitfalls:

- Waiting too late. Small problems are easily resolved. But if you repeatedly turn a blind eye to small problems because you dread confronting them, they'll soon escalate into big problems that aren't easily resolved. Address disciplinary issues as soon as they occur.
- Coming on too strong. The most effective discipline is progressive. You begin by taking small corrective actions, and then if those fail, you proceed to harsher actions. If you threaten to fire an employee for minor offenses, you lose credibility and create an atmosphere of fear and distrust.
- Making discipline finite. Think of discipline as a form of training. Workers aren't fully educated in a day; its' an
  ongoing process. Instead of assigning penalties and walking away, work with employees to help them see the purpose of your directive.
- Confusing discipline with punishment. Discipline doesn't have to be negative. Depending
  on the offense, it can be more effective to reward workers for doing better than to punish them
  for their mistakes. The goal is to encourage workers to adopt positive behaviors because they
  fear the consequences.
- **Ignoring root causes.** Always give workers the chance to explain their actions. You may discover that some procedure or other employee warrants further security.
