Mid-Atlantic USGA Update

They're Back

After what many thought was a quiet spring with regards to annual bluegrass weevil and golf courses making preventive insecticide applications, this insect pest has shown up with a vengeance. Adult populations noted earlier in the spring led many of us to believe that it would be a light year with regard to the weevil populations, but fat chance. Dr. Pat Vittum, entomologist from the University of Massachusetts, echoes this sentiment when she states, "...and what a year it is. I have NEVER seen as high populations as we are seeing this year, and region wide. Hang on, it may be a wild ride!"

Damage to *Poa annua* has been noted at several golf courses in recent days. Larvae are now developed to the point where insecticides will be ineffective. Vigilant scouting must be employed in the coming weeks to monitor adult emergence of the second generation of the 2007 growing season. Just about any contact insecticide will control the adults, although pyrethroid chemistry continues to be the standard for control of adult weevils.

In the southern portion of the Mid-Atlantic Region, active bermudagrass growth is finally occurring. Some winterkill did occur, but only in the northern part of our region. At times this spring, cool, cloudy weather patterns have been a challenge for bermudagrass managers. However, most of the bermudagrass we are seeing now is in mid-season form with exception of shaded areas and winter affected areas.

Overall to date, golf courses are in very good condition, although some *Poa annua* seedheads still exist. Remember, now

is the time to consider what maintenance strategies will be implemented when the summer heat arrives, and it will arrive! If we can offer one recommendation, be proactive. If you wait until anthracnose is active to back off on maintenance practices to encourage green speed, it is too late. If you wait until turfgrass thinning is noted to switch to solid rollers, it is too late. Keep the grass healthy as we progress into the summer, and the golf course will be better for it. While setting arbitrary times to implement conservative maintenance practices is difficult, waiting until damage occurs to back off is risky business. Monitor 10-day forecasts for temperature trends and act accordingly. The summer heat will come; it is not an *if*, it is a *when*.

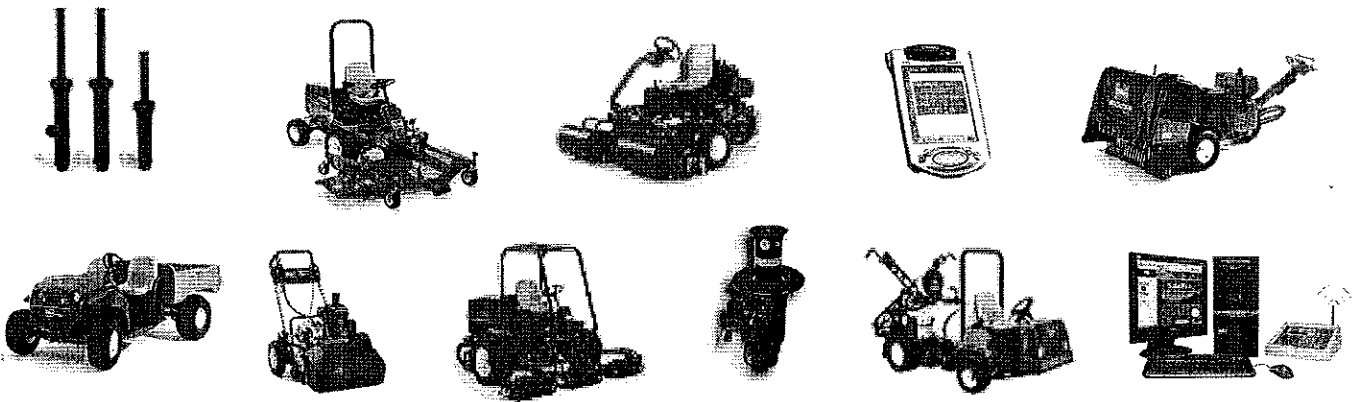
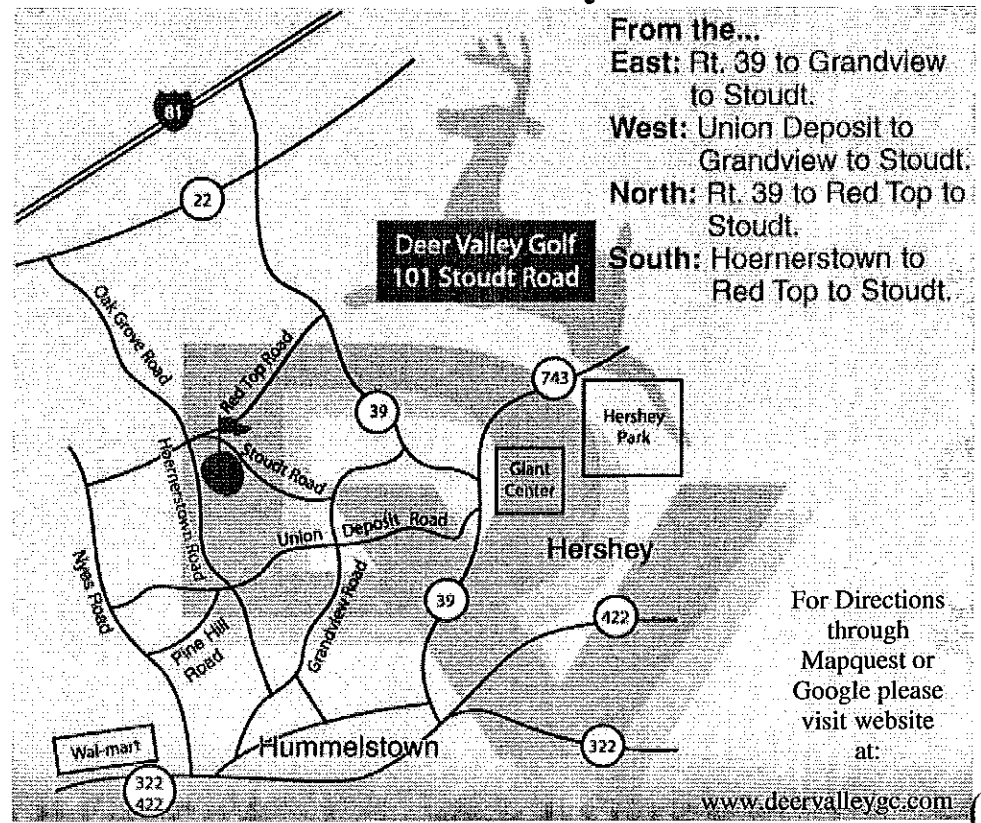

Heather and Gorse

Driving along the other day I started thinking that penguin movies and Michelle Wie have an awful lot in common. Update from Penn State On the Status of the Golf Course Turfgrass Management Two-Year Certificate Program

Most of you are aware that Mr. Carmen Magro, CGCS recently resigned from his position as coordinator of Penn State's two-year certificate program in golf course turfgrass management; and has accepted a position as Senior Agronomist with Floratine Products Group. Carmen has kindly offered his assistance in helping with the transition to a new coordinator, and the entire turf program faculty wishes him well in his new position.

Penn State turf faculty and administrators are committed to continuing the two-year program (now approaching its 50th year of educating golf course managers), and have just accepted a promising new class for the 2007 academic year. Over the next few months we will be consulting industry leaders concerning the future direction of the program, to make sure we are meeting the needs of the golf course industry. Following these discussions, we should be in an excellent position to conduct a national search for a highly qualified individual to serve as our new program coordinator. In the meantime, the Dept. of Crop and Soil Sciences will hire an experienced individual to serve as interim coordinator to oversee the program.

The Rules, Your Course and Its Golf Course Management Staff

Presented by the Golf Course Superintendents Association of America

It's not uncommon to hear a golfer say, "The Rules of Golf are too complicated."

But what's most important for golfers to understand is that many of the rules are actually intended to help them out. For instance, most golf courses have cart paths, sign posts, permanently anchored yardage markers, ball washers, etc. These are immovable obstructions, and golfers are permitted relief from them under rule 24-2.

In addition to those permanent features of the course, golfers and/or their golf ball will interact with the work of the golf course maintenance staff, or with natural situations that affect the course. These are called "abnormal ground conditions" and also offer relief under Rule 25.

For instance, in wet weather, portions of the course can have standing water outside of a water hazard. This is casual water and golfers can also get relief from it under Rule 25.

When the golf course management staff is working on the projects such as resodding, maintaining or repairing the irrigation system, or renovating bunkers, these areas may be marked as ground under repair. In such cases, golfers are entitled to relief from the area.

If the committee wishes to protect an area of the course such as new sod, The Rules of Golf also recommend identifying the area as ground under repair, and requiring players to take relief from it. The recommended local rule is:

"The _____ (defined by _____) is ground under repair from which play is prohibited. If a player's ball lies in the area, or if it interferes with the player's stance or the area of his intended swing, the player must take relief under Rule 25-1."

Of course, there are other times when The Rules of Golf can help you on the course. One of the regular maintenance practices that can have an effect on play is the aerification of greens, tees and fairways. According to The Rules of Golf:

When a course has been aerated, a Local Rule permitting relief, without penalty, from an aeration hole may be warranted. The following Local Rule is recommended:

"Through the green, a ball that comes to rest in or on an aeration hole may be lifted without penalty, cleaned and dropped, as near as possible to the spot where it lay but not nearer the hole. The ball when dropped must first strike a part of the course through the green."

On the putting green, a ball that comes to rest in or on an aeration hole may be placed at the nearest spot not nearer the hole that avoids the situation."

The Rules even offer a specimen local rule for trees that have been planted:

When it is desired to prevent damage to young trees, the following Local Rule is recommended:

"Protection of young trees identified by _____ — If such a tree interferes with a player's stance or the area of his intended swing, the ball must be lifted, without penalty, and dropped in accordance with the procedure prescribed in Rule 24-2b (Immovable Obstruction). If the ball lies in a water hazard, the player must lift and drop the ball in accordance with Rule 24-2b(i) except that the nearest point of relief must be in the water hazard and the ball must be dropped in the water hazard or the player may proceed under Rule 26. The ball may be leaned when lifted."

While the rules don't specifically address the maintenance staff itself, golfers need to remember that sometimes the work to be done puts golfers and the staff on the course at the same time. At those times, a little patience can make for a safer, more productive day for the staff, and produce better golf course conditions when the project is done.
